What is the Global SCLM option?

The Global Supply Chain and Logistics Management option is a specialized option and joint exchange program between the Sauder School of Business, Copenhagen Business School (CBS) and Chinese University of Hong Kong in Shenzhen (CUHK-Shenzhen).

Students from the three institutions study together as a cohort for three terms and take common courses in global supply chain and logistics management.

Why UBC Sauder/CBS/CUHK-Shenzhen

- Common interest and expertise in global logistics and supply chain management
- Geographic location of cities in key regions of the world
- Similar academic programs and academic culture
- Reputation and quality of institutions

Copenhagen Business School (CBS)

Copenhagen Business School was established in 1917. With over 22,000 students CBS is one of the largest business schools in Europe and one of the 8 Danish universities

Accredited by EQUIS, AMBA and AACSB. CBS has thus acquired 'The Triple Crown', an acknowledgement only shared by only 77 business schools worldwide

Copenhagen is the capital and most populous city in Denmark, with a population of 1.4 million in the urban area.

Chinese University of Hong Kong, Shenzhen

The University was established in 2014 with the mission to explore a new path for higher education that bridges China and the world. It seeks to cultivate innovative talents with a global perspective, Chinese cultural traditions and social responsibilities.

Currently, over 10,000 students are studying at CUHK-Shenzhen in six schools.

Shenzhen is the third most populous city by urban population (17,560,000) in China after Shanghai and Beijing. The city is a leading global technology hub sometimes called China's Silicon Valley.

Program Benefits

- Unique and enriched educational opportunity
- International exposure and opportunity to study on three continents
- Cohort-based program of up to 45 students
- Access to multiple business career centres and networking opportunities
- Alumni network across three universities
- With increased demand for graduates trained in supply chain and logistics management giving graduates a competitive edge

Program Structure

- Year 1 and 2 at UBC
- Term 1 of year 3 at Copenhagen Business School (cohorts together)
- Term 2 of year 3 at UBC (cohorts together)
- Term 1 of year 4 at Chinese University of Hong Kong, Shenzhen (cohorts together)
- Term 2 of year 4 at UBC
- Co-op work terms are typically in the summers, Year 4 Term 2, and/or after the international components of the GSCLM programming. All Co-op students typically graduate in 5 years

Curriculum

Meet the regular requirements of the BCom program while studying at three institutions.

Two option courses taken at each school:

- Logistics Clusters (CBS)
- Supply Chain Risk Management (CBS)
- COMM 414 Data Visualization and Business Analytics (UBC)
- COMM 449 Supply-Chain Management (UBC)
- Management of Innovation in China (CUHK)
- Current and Regional Issues in Supply Chain & Logistics Management (CUHK)

Costs

Tuition is paid to UBC. Also need to consider:

- Airfare
- Accommodation
- Personal expenses (meals, entertainment, travel, etc.)
- Study trip to Hamburg (2023 cost approximately \$575 for hotels and transport)
- Residence permit / visa costs
- Expenses for a term in Copenhagen should be similar to Vancouver, while in Shenzhen can be less expensive

Exchange & Option Eligibility

- Maintain status at UBC while away
 Eligible for scholarships and financial assistance
 Pay tuition to UBC (15 credits per term)
- \$431.50 Go Global application fee
- Eligibility: 70% GPA

- Exchange application deadline: December 10, 2025, at 11:59pm
- Completion of COMM 204 prior to departure
